from the President and CEO



Dear Friends,

In 2021, the Scranton Area Community Foundation launched a bold, three-year strategic framework developed with input from our Board of Governors, donors, nonprofit partners, and other community leaders. As we approach the culmination of this three-year period, we are thrilled to share the tremendous growth and impact achieved by the Foundation, all made possible by your support.

Through Women in Philanthropy and other initiatives, the Foundation focused on civic engagement, financial education, and affordable childcare and housing. These open dialogues, which included key partners, will help ensure equity is at the core of community impact objectives.

Responding to rising costs and inflation, our board approved an unprecedented \$1 million special grant distribution and an additional distribution the following year, demonstrating the Foundation's commitment to addressing critical community needs, and in both years, the Foundation administered more grants and scholarships than ever.

In the same period, NEPA Gives raised an impressive \$2.3 million in just 48 hours to support our local nonprofit community. Additionally, our partnership with the City of

Scranton in administering American Rescue Plan Act funding saw \$1 million distributed to Lackawanna County nonprofits, addressing various post-pandemic-related challenges.

In addition to monetary support, the Foundation supported nonprofit capacity-building by hosting 17 training sessions and the fourth NEPA Learning Conference. More than 200 nonprofit professionals gathered over three days during the conference to network and learn from 45 local and nationally recognized experts.

Fueled by your generosity, we have seen significant progress throughout 2022-2023 and look forward to an even more impactful 2024. Thank you for your continued support!

Despite challenging economic times with inflation and market decreases, 2022 and 2023 were successful years for the Scranton Area Community Foundation. Between 2022 and 2023, \$17.5 million in grant funding and direct program support was distributed to nonprofit organizations. In the past two years, we have opened 73 new funds! Through your generous support of funds aligned with the Foundation, corporate funders, and our donors, NEPA Gives continues to raise millions each year to benefit hundreds of nonprofit organizations.


The Foundation continues to support initiatives to combat food insecurity and homelessness. The Foundation's Women In Philanthropy initiative continues to fund women-owned businesses, match savings for home and vehicle purchases and improvements/repairs, and restorative dentistry for women on limited means.

The Foundation's workforce initiative, NEPA Thrives, was selected from 60 applicants nationwide to host an Aspen Workforce Leadership Academy with the goal of educating and supporting workforce development through a yearlong series of retreats, workshops and action learning projects.

As Board Chair, I would like to take this opportunity to thank our donors, professional advisors, and friends of the Scranton Area Community Foundation for your continued support and generosity to the Foundation and to our community.

Since 2014, Women in Philanthropy (WIP), part of the Scranton Area Community Foundation, has empowered women, girls, and families in Lackawanna County.

WIP has continued and expanded many successful programs to help lift women, girls, and their families out of poverty. From the generosity of our 120+ supporters, Women in Philanthropy awarded over \$100,000 in grants and programming support to nonprofit organizations directly impacting women and girls in our community. WIP has matched the savings of 150 local women towards purchasing a home, car, or education, contributing over \$360,000 while also providing financial confidence classes. With over \$1.6 million raised, WIP continues to make a difference.

The Center offers free or low-cost training, technical assistance, and resources to help organizations improve their impact.

The NEPA Animal Welfare Collaborative is a collective of animal shelters, rescues, advocates, and sanctuaries that have come together to advance various animal welfare causes and increase the collective resources available to these agencies. Its mission is to work on initiatives to ensure animals in Northeastern Pennsylvania achieve a happy and healthy life — free from abuse and neglect.

The Scranton Area Community Foundation serves as the convener of the NEPA Animal Welfare Collaborative, which aims to bring together individuals, shelter, and rescue groups to help solve challenges for the benefit of people and animals in NEPA.

NEPA RESCUE VETERINARIAN CLINIC

In October 2022, the NEPA Animal Welfare Collaborative hosted its first NEPA Pet Expo/Animal Care Summit at the Viewmont Mall.

The expo featured a mix of fun and educational events, including vendors showcasing pet products, informational booths on pet care and pet first aid, animals available for adoption, information highlighting the work of local shelters and rescues, a microchip clinic for pets, and more!

To help address the veterinary shortage in Northeastern Pennsylvania, the NEPA Animal Welfare Collaborative in partnership with Indraloka Animal Sanctuary and support from the Robert H. Spitz Foundation, launched the NEPA Rescue Veterinary Clinic. The clinic provides low-cost veterinary care to over 35 animal welfare organizations in Northeastern Pennsylvania. With grant funding, the clinic hired Dr. Leslie Interlandi as a full-time veterinarian.

Together with many community partners, the Scranton Area Community Foundation has created NEPA Thrives, addressing workforce challenges in Northeastern Pennsylvania.

NEPA Thrives aims to enhance the regional economy by tackling issues and finding solutions to workforce challenges such as skills training, digital literacy, and childcare affordability. The Northeastern Pennsylvania Workforce Leadership Academy launched in 2023 as part of this initiative.

In 2022, through a competitive process, the Aspen Institute selected the Scranton Area Community Foundation as one of eight sites nationwide to host a Workforce Leadership Academy. In 2023, 22 fellows from Lackawanna and Luzerne Counties completed the 10-month Northeastern Pennsylvania Workforce Leadership Academy.

In December 2023, the Fellows presented their recommendations to strengthen the workforce ecosystem in Northeastern Pennsylvania. In 2024, the Scranton Area Community Foundation will collaborate with partners to implement these recommendations.

FOR NONPROFIT EXCELLENCE

The Scranton Area Community Foundation hosted its fourth NEPA Learning Conference on September 20 - 22, 2023.

Over 200 nonprofit professionals attended the event in Downtown Scranton, receiving in-depth training from local and nationally recognized presenters at the Hilton Scranton and Conference Center. Ruchika Tulshyan, best-selling author of "Inclusion on Purpose: An Intersectional Approach to Creating a Culture of Belonging at Work," served as the keynote speaker. Attendees experienced three days of networking and interactive sessions, learning from over 45 experts in various fields.





The conference also featured the Nonprofit Excellence Awards, which honored organizations and individuals embodying themes of collaboration, innovation, advocacy, and inclusion. Sponsors included the Moses Taylor Foundation, The Harry and Jeanette Weinberg Foundation, the McGowan Charitable Fund, and many others.

Held every other year, the NEPA Learning Conference will return in 2025.

The Northeastern Pennsylvania Health Care Foundation awarded \$418,000 in its second year towards nursing scholarships for local students as part of its Careers in Care initiative in response to the acute shortage of nurses across the region and its effect on the health and wellness of Northeastern Pennsylvania.

Additionally, through Careers in Care, the NEPA Health Care Foundation has provided grant support totaling \$800,000 to a variety of organizations including Lackawanna College, United Neighborhood Centers of NEPA, Children's Service Center, The Greater Hazleton Partners in Education, Northern Tier Industry and Education Consortium, and Saint Joseph's Center. The Northeastern Pennsylvania Health Care Foundation's Careers in Care initiative is a \$1.7 million commitment over a three-year period (2020-2023).

In addition to the Careers in Care initiative, the NEPA Health Care Foundation is also in the eighth year of a \$3.2 million commitment to the Geisinger Commonwealth School of Medicine (GCSOM)

for scholarship support for incoming first-year medical students from Lackawanna, Luzerne and Wyoming counties. The NEPA Health Care Foundation Scholars program covers full tuition for these scholars, who indicate a commitment to practice medicine in Northeastern PA. The Northeastern Pennsylvania Health Care Foundation is administered by the Scranton Area Community Foundation.

Matching Funds: Amplifying the impact of community-driven initiatives.

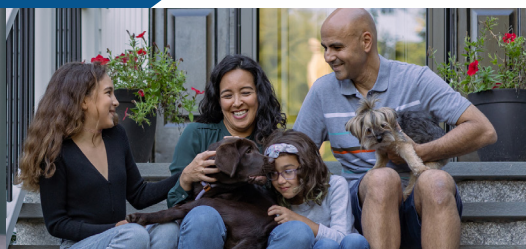
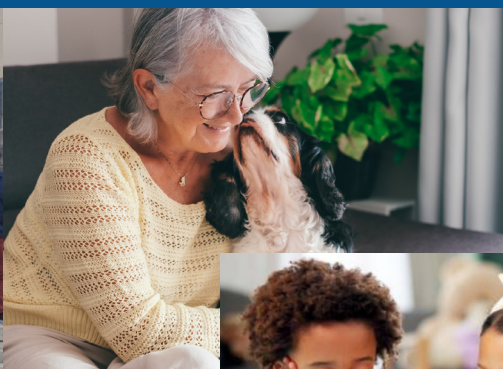
