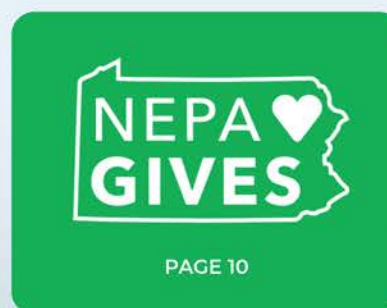
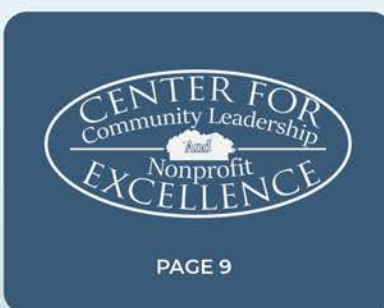
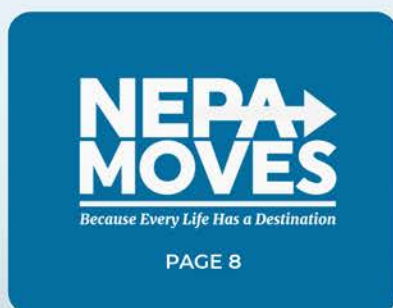
STRATEGIC COMMUNITY INITIATIVES

At the **Scranton Area Community Foundation**, we are proud to serve as a catalyst for lasting, meaningful change in Northeastern Pennsylvania. CELEBRATING A DECADE OF EMPOWERING WOMEN, GIRLS, AND THEIR FAMILIES.

Women in Philanthropy (WIP), a dynamic collective of changemakers working to advance the lives of women, girls, and their families across Northeastern Pennsylvania, continued to drive measurable impact throughout 2024.

In 2024, WIP awarded **\$35,000 in strategic grants** supporting education, economic mobility, and health outcomes. The initiative expanded its financial empowerment programs, advanced a pilot for **restorative dental care**, continued investing in **women-owned businesses through micro-loans**, and sustained its commitment to **STEAM education**.

With more than 125 supporters and **over \$1.6 million raised since its inception**, WIP marked its 10th anniversary by honoring its founders and celebrating a decade of progress.

At the 2024 Annual Celebration, WIP recognized **Carol Shoener and Marylou Grogan** as the year's Margaretta Belin Chamberlin Award and Roseann Smith Alperin Award recipients—two honors that celebrate exceptional leadership, service, and community impact.

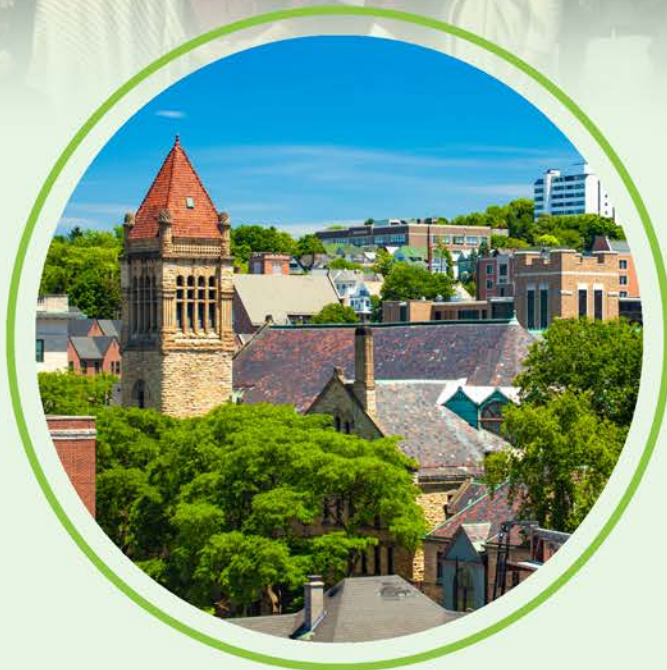




NEPA Thrives is an equity-driven workforce initiative launched by the Scranton Area Community Foundation in collaboration with a wide range of community partners. It was created to respond to the growing need for coordinated, sustainable solutions to the workforce challenges facing Northeastern Pennsylvania.

Grounded in the belief that a thriving economy must work for everyone, NEPA Thrives builds cross-sector partnerships to remove barriers and expand opportunities for workers, families, and employers across the region.

NEPA Thrives aims to invest in solutions that strengthen Northeastern Pennsylvania's workforce through skills training, digital access and literacy, and affordable, high-quality childcare, enabling the region to build a robust, growing economy where everyone thrives.



ADVANCING ECONOMIC OPPORTUNITY ON A NATIONAL STAGE



In 2024, the Scranton Area Community Foundation was selected as one of just ten community foundations nationwide to join the advanced cohort of the Economic Mobility Action Network, a **CFLeads** initiative funded by the **Bill & Melinda Gates Foundation**.

This recognition highlights the Foundation's leadership in advancing economic mobility and equity in Northeastern Pennsylvania.

Through this national partnership, the Foundation collaborates with peer organizations and local partners to strengthen regional strategies, share best practices, and drive long-term, systemic change tailored to our community's needs.



Established in 2019, the **NEPA Animal Welfare Collaborative** is a collective of animal shelters, rescues, advocates, and sanctuaries in the region that are interested in coming together to advance various causes in animal welfare and to increase the collective resources available to these agencies.

To address the post-pandemic rise in feral cats, the NEPA AWC partnered with the **NEPA Rescue Veterinary Clinic** to launch a Trap-Neuter-Release program. In **August 2024**, three free clinic events spayed/neutered, vaccinated, and treated over 100 feral cats in Lackawanna County, reducing disease risks, wildlife impacts, and neighborhood disruptions.



NEPA Moves is a regional mobility initiative led by the Scranton Area Community Foundation in partnership with transit providers, workforce organizations, employers, and community groups.

Created to address persistent transportation challenges in Northeastern Pennsylvania, the initiative works to build a more connected and equitable region.

Rooted in the belief that access drives opportunity, NEPA Moves strengthens cross-sector collaboration to improve mobility and ensure residents can reach jobs, education, healthcare, and essential services.





Founded in 2012 by the Scranton Area Community Foundation, the **Center for Community Leadership and Nonprofit Excellence** empowers nonprofits across Lackawanna County and beyond by strengthening leadership, capacity, and long-term impact.



In 2024, the Center expanded its partnership with **eCornell**, offering nonprofit leaders access to 215+ online professional certificate programs—covering topics from Digital Marketing and DEI to Generative AI Strategy. With 85% of tuition covered through grants, high-quality professional development is accessible at a fraction of the cost.

The Center also supports nonprofits through the **Executive in Residence Consultant Grant Program**, awarding \$500–\$5,000 for one-on-one coaching and strategic guidance. Since 2019, the program has helped dozens of organizations improve governance, infrastructure, and mission impact.

A cornerstone of the Center's work is the **NEPA Learning Conference**, a biennial event providing nonprofit staff, board members, and volunteers with expert-led sessions, workshops, and tools on leadership, inclusion, team culture, and fundraising.

Through training, consulting, and community connection, the Center continues to strengthen the nonprofit sector in Northeastern Pennsylvania.





NEPA GIVES

5 YEARS OF GIVING

THE REGION'S LARGEST GIVING EVENT

The fifth annual **NEPA Gives**, held June 6–7, 2024, raised a record **\$1.23 million** in just 24 hours for 241 local nonprofits across Northeastern Pennsylvania. Nearly 7,000 donors participated in the region's largest day of philanthropy, hosted by the Scranton Area Community Foundation in partnership with regional community foundations and sponsors.

Celebrations included a kickoff event at **PNC Field** with the **Scranton/Wilkes-Barre RailRiders**, as well as local gatherings in Hawley and Stroudsburg, followed by a vibrant block party in **Downtown Scranton** featuring over 30 nonprofits, live music, food trucks, and games.

Thanks to the generous support of local businesses, foundations, and individuals, including the **Moses Taylor Foundation**, **Harry and Jeanette Weinberg Foundation**, and many others, hundreds of thousands of dollars in prizes and matching incentives were awarded.

Since its launch in 2020, NEPA Gives has raised **over \$5.2 million**, supporting hundreds of charitable organizations throughout the region.

In 2024, donor Mary Kopa turned a long-held intention into a living legacy by establishing the Judy Tomes Duffy Music Education Scholarship Fund. What began as an estate-planning goal grew into an opportunity to make an immediate impact on local students pursuing music education.

Mary has now established four active scholarships and one fund with the Foundation, each intentionally designed to reflect her values and the causes closest to her heart.

Judy, an only child from Dunmore, PA, discovered her rare musical talent at age four and grew into a concert-level classical pianist. A Dunmore High graduate, she earned degrees from East Stroudsburg University and Marywood, taught in the Abington Heights School District, and later supervised special education for the Northeast Intermediate Unit, where she also formed an adult special-education choir.

A devoted student of classical music, Judy could identify orchestras by ear and traveled widely to experience concerts, opera, and ballet. She sang with The Marywood Singers and The Choral Society of Northeastern Pennsylvania and served as Choral Director at Our Lady of the Snows Parish.

Deeply engaged in community service, she served on the boards of the Northeastern Pennsylvania Philharmonic and The Association for the Blind, chaired major local events, co-founded a nationally recognized program for displaced homemakers, and was nominated as a “Northeast Woman of the Week” by the Scranton Times-Tribune.

Judy was gifted, generous, and joyful, and her love of music and commitment to others form the foundation of this scholarship.
